Mandated Benefits

Student Employees: Program funds cover Workers' Compensation and Unemployment Insurance. Fresno State student employees must carry the following units during the academic year/summer:

- Six (6) or more units for undergraduate students
- Three (3) or more units for graduate students

Note: If a student does not carry the required units, employer and employee are subject to FICA and Medicare (7.65%).

Non-Student Employees: Program funds cover Workers' Compensation, Unemployment Insurance, FICA and Medicare.

Medical Insurance: Monthly premium is calculated based on the number of dependents and the plan selected. The Employer Contribution towards monthly premiums will assume to be 100% for the total premium, unless the program elects an alternative funding option*.
